

Watercycles™ Warranty

Limited Warranty: Watercycles™ Energy Recovery Inc. warrants to the property owners and succeeding owners that the Watercycles™ Energy Recovery device shall be free for four years from defects in material and workmanship, under normal conditions of use, when used for potable water distribution.

This limited warranty DOES NOT cover the following:

1. Defects or damage arising from shipping, installation, alterations, accidents, abuse, misuse, lack of proper maintenance and use for other than intended purpose, in all cases whether caused by a plumbing contractor, service company, the owner or any other person.
2. Deterioration through normal wear and tear.
3. Postage or shipping costs for returning products for repairs or replacement under this limited warranty and labor or other costs incurred in connection with product removal or installation under this limited warranty.
4.
